Consumer Electronic Calculator

New Remington Consumer Electronic Calculators are warranted to be in satisfactory operating condition when purchased. Should the calculator prove defective in material and workmanship within 90 days from date of purchase, repair will be made without charge for parts and labor.

This warranty does not include repairs required due to misuse, neglect, damage caused by improper packing, nor expendables such as batteries, adaptors, power cords and carrying cases.

NOTE: Before assuming battery powered electronic calculators to be defective, the customer is cautioned to install a new set of batteries to ensure the problem is not due to weak batteries.

Customer is responsible to provide Proof of Purchase date. Save invoice or sales slip.

Upon receipt of the attached Service Agreement Contract Card and a check or money order in the amount of \$12 plus applicable sales tax payable to Sperry Remington, the following articles of agreement will become effective:

1. Sperry Remington will repair or replace with a comparable unit (at our option) for three years in addition to the 90 day warranty.
2. All parts and labor are included except batteries, adaptors, lost power cords, or carrying cases.
3. Agreement does not include repairs due to misuse, neglect or damage caused by improper packing.

Please note that this Service Agreement is offered at time of purchase, ie, within one month of purchase date.

To take advantage of this exceptional service coverage, send the attached card properly filled out with name, address, zip code, date of purchase, with *Proof of Purchase* and check or money order payable to Sperry Remington to the nearest Service Center.
